- Map youth mental health resources and gaps in 4 county area
- Plan Southern Arizona Youth Stigma Reduction Conference (Oct 2020)

#### Intermediate Task Force Objectives for: March 2019-May 2019

- Continue to contact 23 "priority list" Alliance member prospects, provide information on the initiative and invite participation to add at least 5 more to the current total of 27 member organizations and individuals in FY 1
- Develop and finalize materials to describe Alliance Membership donor levels and benefits and a "case for support" document and combine with Alliance Commitment Agreement
- Finalize a "fill-able" form to collect information on Alliance Members for posting on website
- Identify intern able to collect information for constructing the youth mental health services resource map
- Launch HH4Y website
- Continue to recruit new members for the Capacity Building Task Force

- Resource map: (1) reviewed and approved the draft job description for a student intern to collect information on youth mental health services via web and phone search as a summer project; (2) Family & Community Medicine can fund this internship; (3) Jansen and Higher Ground want to participate in this project as part of an on-going effort to develop their own proprietary software that will match service providers and clients

- Alliance Member Prospects: (1) reviewed prior assignments to note results of any contacts made; (2) agreed to continue to contact prospective members from the Priority List with no new assignments made this month; (3) discussed conference call set for 4/1/19 with Cameron Cobb from Banner Health with Jansen agreeing to take the lead in the discussion with this prospective Alliance Member
- **Communications**: Cindy Godwin was absent and, therefore, did make a report on the communications plan which she has drafted including the website launch. The launch is dependent on the set up of a new payment platform through NAMI Southern Arizona.
